- **This form must be fully completed before acceptance by the Treasurer. All required monies must accompany the submission of this form.** Cheques are to be made out to "TRACS". The treasurer will issue receipts for all monies.
- **For direct deposit to the club account** - Name "TRACS", **BSB 484799, A/C No 009339955**, make the direct deposit before submitting the application form, use your surname and initials for the bank deposit reference, and provide some evidence with your renewal/application form to indicate that a direct deposit has been made. Applications will only be processed when **both the direct deposit and completed application forms** are received.
- Junior members must be aged 17 years or less at the start of the club year (1st July)
- Members are required to inform the secretary of changes to their contact details, **especially their email address.**
- Insurance – see [http://maaq.org/wp-content/uploads/2011/08/Summary\\_Brochure\\_Willis.pdf](http://maaq.org/wp-content/uploads/2011/08/Summary_Brochure_Willis.pdf) for cover and excesses which apply to your MAAA membership
- Any member under instruction shall have no claim against another member who provides instruction/tuition/assistance in the event of damage to the aircraft owned by the member under instruction. The MAAA insurance policies including the member to member insurance cover excludes damage to model aircraft irrespective of the cause.
- Half of the MAAQ and TRACS fees are payable when a new member joins on or after 1st January of any year.
- **Proposer and seconder are required for all new members – see page 2.** Submission of a new member's application form does not automatically mean acceptance by the club.
- Green fees are payable **either** by the **\$2** weekly option (honour system) **or** the one-off yearly non-refundable payment of **\$52**

**Code of Conduct Membership Agreement**

1. All members shall abide by the TRACS Safety Rules and Regulations with regard to the flying and operating of radio controlled model aircraft.
  2. All TRACS members shall conduct themselves in an appropriate manner showing respect and courtesy at all times when interacting with fellow club members, visiting club members and visiting public.
  3. All members are expected to follow direction from Safety Officers or club officials when deemed necessary.
- Note: Even if a member feels he has been unjustly dealt with or disagrees with that direction, he must first follow that direction.
- Only after the event may the member seek redress through the committee - the committee's ruling being final.
4. Verbal or physical abuse by any member will not be tolerated at any time and depending on the severity of the abuse the member may be suspended or expelled from TRACS.
